On behalf of our members and the public we request that CPSO investigate the doctors who were the focus of recent articles in the Globe and Mail. Both <u>Licensed to bill: How doctors profit from injury assessments that benefit insurers</u> and <u>Insurance assessment firms altered</u>, <u>ghostwrote accident victim reports</u> columns reflect the need of increased regulatory oversight to protect vulnerable patients. We are asking CPSO to be pro-active before more harm takes place.

The list of CPSO members mentioned in these articles and earlier this year in the National Post report <u>Hired gun in a lab coat:</u> <u>How medical experts help car insurers fight accident claims</u> is extensive and it appears most, if not all, of these doctors have been in front of CPSO on more than one occasion. Every judicial criticism is a reflection of harm to victims and a statement on the lack of regulatory authority; it is a failure to be pro-active then and now as Ontario's accident victims are attending medical exams today.

We hope you'll take steps to ensure that the concerns of Ontario's accident victims are taken seriously and investigate the damage caused by the small subset of doctors for whom "do no harm" has no meaning. Our goal is to protect MVA victims and the public at large from doctors who harm.
